# PADBURY PARISH COUNCIL Minutes of a meeting of Padbury Parish Council held at Springfields Pavilion on Tuesday 9<sup>th</sup> April 2019 at 7.30 p.m.

**Period of Public Questions**: Mr Jackson, a Springfields resident, addressed the council as the verge by the side of the road had not been mown along with the other grass areas in Springfields and asked whether the parish council owned that particular piece of land which is why it had been omitted from being cut.

Cllr Long advised all grass verges in Springfields belonged to the Housing Authority so it would be their responsibility to cut the grass and would need to check with them why this area had not been mown.

The developers have now built enough parking for the contractors to be able to use their site rather than the pavilion car park and aim to park all vehicles on site within the next couple of weeks. The council expressed their thanks to Mr Jackson for changing the times of opening and shutting the gates to accommodate the contractors.

Mr Jackson also spoke about damage to the pavement which had been cracked by heavy lorries by the site next to the development.

Cllr Long advised he would visit the site to take some pictures of the damage and discuss the plan for remediation of works with the site manager.

The water has now been restored to the allotments on a temporary basis by the developers who have stated they will reinstate a new permanent pipe once the development has been finished.

# 139.0 Highways

- Bucks Rights of Way Improvement Plan. Cllr Roberts obtained and circulated the ROW maps before the meeting along with the response to the survey for discussion. The council expressed their thanks to Cllr Roberts for his work on the response. RESOLVED for Cllr Roberts' to respond to the survey.
- Another query has been raised regarding placing a bus shelter at the stop opposite the New Inn (previously discussed in PPC/06/1819 November 2018). The council have a power (not a duty) to provide bus shelters (Local Government (Miscellaneous Provisions) Act 1955. Section 4(1)). Consent would need to be obtained from BCC Highways before construction and would have an estimated cost of £2,000 £4,000. As the current position of the bus stop is in the narrowest area of the footpath / cycleway it would be difficult to be able to construct. RESOLVED for clerk to contact BCC Highways to check the technical feasibility given the road safety issues associated with the cycleway. Cllr Long to contact resident giving reasons for consideration.
- In the planning meetings of the development opposite Springfields, it was a condition that a
  crossing was to be placed to allow for improved pedestrian access. Cllr Long reviewed the
  planning documentation and was unable to find the condition. RESOLVED for Cllr Roberts
  and Cllr Long to review s106 documentation to check which phase of the development
  includes the crossing being built. Cllr Long to draft letters to AVDC and BCC Highways
  requesting the information.
